Internal audit is the periodic independent review of a council's internal controls resulting in an assurance report designed to improve the effectiveness and efficiency of the activities and operating procedures under the council's control. Managing the council's internal controls should be a day-to-day function of the staff and management and not left for internal audit.

The council is required to take appropriate action on all matters raised in reports from internal and external audit and to respond to matters brought to its attention by internal and external audit. Failure to take appropriate action may lead to a qualified audit opinion.

I carried out the year-end audit of Farthinghoe Parish Council on 20th April 2018. I would take this opportunity to thank Philippa Clayton, the Parish Clerk for her help and assistance.

Prior to the visit I reviewed the information available on www.farthinghoeparishcouncil.org
I was able to access a well ordered and detailed set of documents and records. By examination of these documents & records plus further questioning during the visit, I tested aspects of the Council's internal controls as required for the Internal Audit section of the Annual Return Part 2 and notwithstanding the items noted below, I am satisfied that effective policies and procedures together with systems to manage, monitor and control the Council's business are in place. Accordingly, I was able to answer 'yes' to all relevant questions and have signed the Return as required.

- All points raised in last year's report have been addressed
- The Clerk's contract states they are the Clerk and RFO therefore appointing the RFO each year is unnecessary.
