
## FARTHINGHOE PARISH COUNCIL MINUTES OF MEETING

20/08/764	To determine responses to recent planning applications	
	764/1 Solar Farm. The PC had responded to the information put out from SNC and had stated that an Environmental Impact Assessment should be done at this early stage. SNC have now informed us that they are insisting one must be done. SNC have further intimated that they do not feel the land is suitable for such a large installation.	
	764/2. Planning application S/2020/0763/FUL. This was responded to and recorded in the minutes of 10 June 2020 (20/06/753).	
20/08/765	To discuss traffic matters for the village. 765/1 Vehicles from Limes Farm using Manor Lane to exit. The council understands that SNC are due to issue an instruction to comply with the current Planning Conditions.	
	765/2 Road markings Charlton Way. This has been reported and we are waiting for a reply from NCC Highways. A further question has been asked as to why this deficiency has not been picked up in any routine inspection by NCC highways.	
	765/3 Blocked drains Hinton in the Hedges Road. NCC are	

	sending a representative out to inspect. A further complaint has been submitted by a consultant on behalf of a local resident. The resident has been promised a reply by 21August 765/4 Pedestrian Crossing Upgrade. We are given a weekly proposed works sheet by KierWsp who are the contractor for NCC. At present it is still proposed to complete the work in September, but no formal start date is given. We will continue to monitor the proposed start date.  765/5 Road markings at the junction of Main Road with Baker Street. This has been reported and we are waiting for a reply from NCC Highways. A further question has been asked as to why this deficiency has not been picked up in any routine inspection by NCC highways.	
20/08/766	Bypass update.  It has been circulated that a public consultation will take place in September/October 2020 and that SNC will publish their preferred route in January 2021. Cllr Morris will liaise with Andrea Leadsom MP in October to ensure that plans after January 2021 are made known to interested parties. Ian McCord, Leader of SNC and interim leader of the new Unitary Authority has been asked to state that all monies promised by SNC and NCC towards the by-pass planning and consultation will be ring-fenced after the merger of the authorities. 20/08/767	Maintenance matters 767/1 The grant application for the purchase and installation of 2 new bus shelters has been submitted to SNC. The grant panel are meeting on 24 August to decide on all applications. We will be notified within a few days of the decision. It was agreed that in the event of us not getting the full monies to replace both shelters, further applications to other organisations would be made and that the allotments shelter was the priority of the 2.  Cllr Bankes-Jones has gained approval for the hedge to the allotments to be trimmed to allow the proposed new shelter to be recessed.  Cllr Willett will contact NCC to obtain the permit to install the	DW
20/08/768	shelters once we are ready go ahead and purchase them.  Childrens' Playpark Cllr Morris stated that the rules for the play park use were imposed after a risk assessment was carried out in line with the actions of surrounding councils, were not being adhered to. People were not properly social distancing and were having large picnics in the park and not clearing up their rubbish afterwards. He has spoken to the groups after their breaches, but the same people were doing the same again a few days later. Cllr Dashwood felt that with the current hot weather people should be allowed to consume food and drink in the park. It was resolved that Cllr Grant would monitor the use of the park and	BW

report back in September regarding these observations. It was further <b>resolved</b> that the current management of the facility needs to be addressed with the volunteers committee who are currently responsible for it.	MM
