## 7. Land Registry: Registration of grass areas at junction of Queens Street and Charlton Road and Cockley Road and Main Road.

Cllr Mellor had not ordered the CD of map showing the location. Cllr Dashwood still needed to see if he could locate a map that may give a clue to the previous owner.

**Update:** The surveyor carried out his inspection and reported back that the Land Registry had turned down the application and the fees (£60) have been returned.

In summary there is no problem with the Farthinghoe Parish Council maintaining the two grass areas on behalf of the village, but since the land is not bounded, no one else could claim the land, unless by deed of the original land owner.

## 8. Annual Parish Meeting

This will take place on  $10^{th}$  April in the Village Hall at 8.00pm after the usual monthly Parish Council meeting.

The Clerk will include in April's edition of the Chronicle.

### 9. Grass-cutting

The Clerk was asked to write to Jon Hampson to explain that the contract for 2013 did not include hedge-cutting at the Village Hall. The Chairman of the Village Hall Committee had already been advised of this.

The contract would commence week beginning 1<sup>st</sup> April 2013 with the grass in the playground being cut every two weeks. The areas at the Cockley Road junction and Charlton Road junction would be strimmed monthly.
