6. Traffic Issues:

Cllr Grant reminded councillors of the issues that had been raised at a meeting in October 2013 with Andrea Leadsom MP, County Councillor Ron Sawbridge and David Farquhar from NCC where it had been agreed that there would be a solution before the Grand Prix 2014.

Proposals: 20 mph past school.

20 mph past the playground in New Road. The request for a flashing "Slow Down" sign had been refused as there is no power supply in the vicinity.

Signage – Unsuitable for HGV's

There had been no update.

7. Adoption of new Standing Orders

It was agreed that Farthinghoe PC adopt the new Standing Orders.

8. Farthinghoe Chronicle:

8.1 Advertising

In the last 18 months the editor had only had 3 requests to advertise in the Chronicle. The number of pages determined the amount of space available and who would be eligible to advertise in the Chronicle and who would co-ordinate and collect fees? This should not be the responsibility of the editor. There are already numerous publications distributed in Farthinghoe that include advertising for local businesses therefore, it was agreed that the Farthinghoe Chronicle should not include advertising other than from Limes Farm and The Fox. Other businesses could be offered the opportunity to add their names to a list that could be included once a year and then retained for future reference.

8.2 Infringement of Copyright

A poem called "The Dash" had been printed in the Farthinghoe Chronicle and then published on the web site and Dash Management had emailed to say this was an infringement of copyright. The poem had been removed immediately and advice was sought from NCALC and the PC's insurers. The Chair had obtained information about the number of hits on the website and it would be explained that a Parish Council is a not for profit organisation and only has a limited amount of money at its disposal, neither is the Chronicle a profit making publication. Was there anybody in the village who may be able to advise? Ian Dorward or Siobahn Tatum?

This is certainly a lesson learned!

9. Farthinghoe's Conservation Area Appraisal and Management Plan Consultation

As Farthinghoe does not have a village historian Cllr Thomas agreed to look at the documentation.

10. The Local Plan: Call for sites

Cllr Thomas would contact SNC to get an update on what the PC needed to do next. Could the PC nominate sites for development or was this for the landowners themselves to come forward with suggestions?

12. Community Enhancement Gang

Some of the work requested was not within the remit of the gang and the PC had been asked to prioritise the work in case it could not all be completed within the one day allocated to the village. Cllr Thomas would arrange to meet with the gang on 8th August.
