- **2. Minutes of the meetings** on 11<sup>th</sup> March had been circulated. They were taken as read, adopted and signed.

### 3.1 Internet Speed

Cllr Wall's article in the Chronicle had prompted one response from a business in Farthinghoe and two other personal ones. The Chairman would mention it in his report to the APM and further enquiries would be made.

# 3.2 Grass-cutting and hedge-cutting at the Village Hall

It was agreed that Edge2edge would cut the Village Hall grass at a cost of £50 per cut. The Village Hall committee had access to a ride on mower and would do an extra mow if required prior to an event.

The Leylandii hedge was no longer going to be cut by Tim Wright. The hedge would need trimming twice during the year and Cllr Wall had obtained a quote for £80 per cut. The Council agreed to pay for this year but the Village Hall Committee would need to do some fund-raising in the future. Cllr Grant would raise at the next Village Hall meeting. The Parish Council was reminded that the Village Hall was available to hire.

**4.3** The Clerk had received an interim pay award that was only back dated to September 2008. The final figure for 2008 was only agreed in March 2009 and the increase, in line with the current NJC salary point SCP25 at £11.074 per hour, will take effect as from January 2009. The Clerk's contract is for ten hours per month giving an annual salary of £1.328.88 payable in four quarterly payments of £332.22.

#### 6. The Fox

The address on promotional literature was incorrect: it should be Baker Street not Baker Lane. Opening night for residents will be on 22<sup>nd</sup> April followed by a second opening night for guests, press etc. on 23<sup>rd</sup> April and then open for business on Friday 24<sup>th</sup> April.

#### 7. Traffic Issues

**7.1** A traffic count is taking place in Charlton Way and Chapel Lane but it is believed that the camera is pointing the wrong way in Charlton Way.

The village name signs still need to be cleaned.

**7.2 Rightracks** signs had been erected on the identified roads. Entrances to villages on these roads will be marked with gateways.

The Clerk informed the Council that there is now a sign on the B4525 advising lorries to use the B4525 rather than the road to Northampton via Moreton Pinkney.

The Rightracks project is also planning car craft courses for the under 16's to give them the opportunity to learn how to control a car. Older drivers may also be included.

#### 8. Village Website

The site is ready to launch along with a link to the pub site. The Limes site is still undergoing development. It has been suggested that hiring costs for the Village Hall should be included on the site.

#### 9. Planning matters

**S/2009/0264/A** for three free standing **signs advertising** The Fox. One on the north verge of A422 approx 18m north-west of entrance to Limes Farm, one on the north verge of A422 opposite junction with Queens Street and one on the south verge of A422 at junction with Charlton Way. The Council objected to the proposal to put a sign on the

village sign at the junction with Charlton Way. If there was to be a sign at that point then it needed to be on a self supporting post. There were no objections to the other two signs.

There were further amendments to the application for The Limes.
