9. Planning Matters

- **9.1** Permission has been granted for S/2010/1300/FUL (resubmission of S/2010/0546) for a dwelling and garage on land adjacent to Abbey Lodge, Cockley Road.
- **9.2** Permission had also been granted for **S/2010/1232/FUL** for a rear dormer extension (Retrospective) at **Corner Cottage**, Chapel Lane.
- 9.3 An application, S2010/1519/TCA to reduce upper eastern crown of Pine tree by 1.5
- -2.0m and crown raise to 5.2 over carriageway at **The Old Rectory**, Old Lane had been submitted to SNC
- **9.4** The application S/2010/0435/FUL for a base camp complex for recreational paint ball games (Retrospective) at Walltree House Farm Steane (Farthinghoe parish) has been given permission.
- **9.5** The appeal against SNC's decision to refuse the application to rebuild part of Cockley Barn to create agricultural office and workshop and for a barn conversion to residential use at **Cockley Barn Farm** has failed.
- **9.6** The Parish Council had not commented on **S/2010/1386/FUL** for a portal frame building for storage of hay and straw at **Gooseholm Fields Farm**, Banbury Road Brackley because it was not important to Farthinghoe. It has since been given permission.
- **9.7** Villages within 5kms of Spring Farm, Welsh Lane, Helmdon have been consulted regarding the proposed wind farm at that location. Action groups have held meetings in Marston St Lawrence

- 1. The editor of the Farthinghoe Chronicle, Marjorie Tolchard, who recently passed away, was a member of the PCC. Did the PCC wish to keep control of the publication? The future of the Farthinghoe Chronicle would be an agenda item at the next meeting.
- 2. Were the wires on the BT post in Charlton Way causing the post to lean? The Chairman would make enquiries.
- 3. The litter bin outside Far View House still needed to be replaced. The Clerk will follow up.
- 4. According to an EU directive all mercury vapour street lights will need to be replaced. **Update:** There are no street lights of this type in Farthinghoe.
