1. Apologies: None.

2. Minutes of previous meetings on 13th **April and 11**th **May** had been circulated prior to the meeting. Under Public Time (page 614) it should have stated that Mr Neil Downing was a parent governor at Silverstone School. The minutes were amended, taken as read, adopted and signed.

3. Matters arising:

3.1 Parish Enhancement Gangs.

What did the Parish Council want the gangs to do? A request had been made to NCC/MGSWP for all signs, within the village and on roads approaching the village, to be cleaned. A further request was also made to cut back vegetation from signs and footways. This request had been made before the deadline on 3rd June. Some road name signs had faded but this would be the remit of South Northants Council and not the County Council.

6. Traffic Issues

The Chairman had invited residents to comment on the re aligned junction of Cockley Road and Main Road. He had received four negative responses but the counter argument was a letter from school, with the support of many parents, thanking the Parish Council for making the route to school safer. The school's travel plan, signed off by NCC had allowed for contributions from children and parents and included was a

photograph of a child stepping onto the crossing and a driver apparently ignoring the red stop sign.

Comments from objectors were noted but there was no budget for any changes. All comments would be passed to County Councillor Ron Sawbridge.

The areas where larger vehicles mount the kerb would be strengthened with hard core under the grass.

7. Almshouses in Farthinghoe

Cllr Forbes thanked the Parish Council for the £200 donation and advised that one of the Almshouses was currently vacant. It was hoped that a potential tenant could be found in Farthinghoe but if not, the invitation would be extended to the surrounding area.

8. Grass area at junction of Queens Street and Charlton Road

This had been raised at the APM and as it did not belong to NCC or SNC; could the Parish Council own it?

It was agreed that the Parish Council would try and establish ownership and it could then be maintained and perhaps made into a more attractive entrance to the village. All previous correspondence was passed to Cllr Downing who agreed to follow up.

9. Information/notice board for near school

It had been agreed that the original cost was too high but the cost was now to be split three ways between the Parish Council, The Fox and The Limes with each paying £747.00 to cover the cost of the board itself, the graphics and installation. The Chairman had contacted SNC Planning and NCC Highways. The area in question did not belong to Highways and it was agreed that the sign could be erected between the pavement and the school fence. There were no utilities in that area either. The sign would need to be added to the Asset Register for insurance purposes.

10. Moles in Playground

There had been no new mole activity reported but if mole catching needed to be carried out a sign should be erected to that effect and the gate locked while work in progress.

11. Planning Matters:

The Parish Council supported S/2011/0563/FUL proposing a porch, rear and side extensions, canopy roof to rear to form car port at The Old Forge, Main Road. It also supported S/2011/0624/FUL for 9.9 kw Solar PV system onto the roof at Walltree House Farm. Steane.
